#### **Comments from Board Members or Officials**

**Revenue Commissioner Joyce Fuller** lets the Commission know she that sent them a copy of the Homestead Act for Disabled citizens to look over. Joyce Fuller also discusses with the Commission the hardship of the internet outage due to the storms and various options to ensure it doesn't happen again.

**Sheriff Jon Daniel** informs the Commission that the Sheriff Department received and opened bids for the commissary services at the County Jail. They have selected Kimbel's Commissary Services. He states that, in the past, there was an agreement that was set, but he would like to enter into a contract and have it approved by the Commission as advised by the Sheriff's Association.

Cleburne County Attorney Jason Odom states all contracts must go through him before being approved by the Commission. A resolution can be added stating approval pending County Attorney's approval and grants the Chairman to sign the contract.

## Resolution #5538

Whereas, Section 14-6-1 of the Code of Alabama (1975) vests the Sheriff with the legal charge and custody of the jail in his county;

Whereas, Section 14-6-40 of the Code of Alabama (1975) provides that the Sheriff shall be responsible for the feeding of prisoners in the county jail under his jurisdiction;

Whereas, Section 14-6-42 of the Code of Alabama (1975) states that the feeding of prisoners shall be from funds paid for by the state in the amount of two dollars and fifty cents (\$2.50) per day for each prisoner and from an account designated the Prisoner Feeding Fund pursuant to section 14-6-47 of the Code of Alabama (1975);

Whereas, the Prisoner Feeding Fund pursuant to section 14-6-47 of the Code of Alabama (1975), has an emergency cost overrun and, pursuant to section 14-6-51 of the Code of Alabama (1975), the County Commission in conjunction with the Sheriff seeks to apply for funding from the state from the Emergency Prisoner Feeding Fund; and

Now be it resolved, that the Cleburne County Commission hereby authorizes the Chairman to jointly apply with the Sheriff to the state Comptroller for funding under the Emergency Prisoner Feeding Fund.

## Resolution #5540

Whereas, Commissioner Emmett Owen wishes to use \$2,500.00, Commissioner Laura Cobb wishes to use \$2,500.00 and Commissioner Mark Truett wishes to use \$1,000.00 from their discretionary funds for the Cleburne County Chamber of Commerce to fund the Boy Scouts for their improvement work;

## Reports from staff:

A. The County Administrator, Lisa Copeland informs the Commission that the Audit is going well so far. She states that she is still working on finding a lower insurance

rate. She states that Parnell found 2 new underwriters, one being Auto Owner's which will cover property and all vehicles aside from Sheriff Department vehicles. She states the other underwriter will cover the Sheriff vehicles. She discusses discounts going with the option of Auto Owners being paid in full and the other underwriter being paid every 3mos for the time being. It will save us \$23,000 and will go into effect April 1st. She states she will still be looking into other insurance companies in the meantime. She also states the ACCA will do all their inspections at one time before giving a quote which will be done in the fall.

County Attorney, Jason Odom would like to state for the record he was not aware of the search for new insurance or the selection of Auto Owners. He states he is the area Attorney for Auto Owners Insurance and that he did not, in any way, shape or form encourage this decision.

- B. The County Engineer, Lee Estes discusses the extensive damage to 14 different sites, from the recent storm. They expect to have the major affected County roads repaired and opened within the next couple of days.
- C. The County Attorney, Jason Odom does not have any updates.
