Comment from Citizens

Ms. Robi Mobley, Director of Hearts, is present to give the Commission an annual report and details of the 7th Annual Day of Hope BBQ set for Saturday, April 13, 2019. She thanks the Commission for the support they give with the funding for the power bill at the Heflin office.

Mr. Don Davis addresses concerns of the areas of cracking in the asphalt on the Chief Ladiga Trail. Chairman Ryan Robertson gives the Commission a history of the support for the development of the trail. County Engineer Lee Estes informs the Commission that he has applied for a grant to replace up to 150 feet of asphalt where there is cracking.

Ms. Neva White discusses stray animal neglect in the area where she lives. Commissioner Jake Durham states that animal abuse is a criminal offense.

Mr. Ron White discusses the possibility of closing a portion of County Road #812 and his concerns are that the mandatory garbage vendor, Advance Solid Waste Disposal is not adhering to the following three stipulations in their contract: trash to be removed at least once per week, wind-blown matter, and charges for late fees.

Ms. Martha Lavender and Dr. Bridgett Burney with Gadsden State Community College to addresses the April 2019 National Community College Month and informs the Commission of the FAME program that the Ayers Campus is going the launch.

WHEREAS, Alabama's public community college system is the State's single largest system of public higher education and is Alabama's most affordable and accessible system of higher education; and

WHEREAS, the three foundational pillars of the Alabama Community College System –academic transfer, workforce development and adult education – enable us to make a positive impact on people we serve annually and the people of our great state; and

WHEREAS, with our unified network of 24 community and technical colleges, including Marion Military Institute (one of only three public military two-year colleges in the country), and more than 130 locations, we are firmly planted within easy reach of every community in this State. Additionally, the Alabama Technology Network provides innovative technical assistance to hundreds of businesses each year; and

WHEREAS, in 2018, the Alabama Community College System served more than 168,000 students, and awarded 19,321 degrees and certificates; and

WHEREAS, 14,469 students participated in the Alabama Community College System's dual enrollment and early college programs, providing high-achieving students with rigorous courses beyond those offered at the secondary level, increasing college access to those who would not otherwise be college bound, preparing them for high-wage, high-demand occupations; and

WHEREAS, more than 509,357 students in Alabama's community colleges have utilized the Statewide Articulation and Transfer Reporting System to assure the transfer of their academic work toward bachelor's degrees at four-year institutions since the articulation agreement's inception in 1998; and

WHEREAS, the Alabama Technology Network has worked with more than 3,500 Alabama companies over the past decade, providing technical assistance that improved efficiency and profitability – ATN's work is credited with saving or retaining 12,100 jobs during that period; Alabama businesses, with the help of ATN, retained and increased sales by more than \$322 million during 2018; and

WHEREAS, more than 421,000 working-age adults in Alabama have neither a high school diploma nor a GED®. The Alabama Community College System awarded more than 2,937 GED® diplomas, 382 secondary school diplomas, 2,656 National Career Readiness Certificates and served 28,525 participants through its adult basic education programs in FY 2018; and

WHEREAS, the Alabama Community College System remains committed to its mission of educating and training the people of Alabama, thus building stronger communities, a stronger workforce and a stronger economy; and

WHEREAS, April is recognized nationally as Community College Month; and

Item B. Funding request Cleburne County Search and Rescue

The Commission discusses the request from Cleburne County Emergency & Rescue Squad, Inc. dba Cleburne County Search and Rescue, a non-profit organization for funding in the amount of \$7500. The said monies are to be allocated for up to \$5000 for liability insurance coverage and up to \$2,500 for vehicle maintenance, training materials, and/or activities.

Commissioner Jake Durham makes a motion to table the request until further discussion. He wants to discuss issues of their bylaws with the sheriff.

Commissioner Emmett Owen is of the opinion that the agency is good stewards of the funding and will use any future allocations to the best interest of the department.

Commissioner Laura Cobb wants the Cleburne County Search and Rescue to stay active and does not want the agency to feel the Commission is not supporting them by delaying this request.

Resolutions #4961

The Commission approves to table the request of Cleburne County Search and Rescue for funding allocation of \$7500 until the next Commission meeting after discussion with the Sheriff as it relates to the Search and Rescue bylaws.

Commission Jake Durham is requesting to add to the agenda of today's meeting to extend 1300 feet of County Road 802, a dirt road, to the county road maintenance schedule. He asks the County Engineer if we have a plat of this road showing that it stops at County Road 802 as he believes it has been maintained in the past. This extension would benefit the four houses on this section of the road.

Commissioner Terry Hendrix asks if this requires an easement, right-of-way document, or public hearing. He asks if the Commission can maintain a road that is not an established county road and if it will become a permanent county road if the Commission chooses to maintain this portion.

County Attorney Jason Odom informs the Commission that it is a descriptive easement.

County Engineer Lee Estes states that there is not a plat of this road; however, there is a record of the county roads on a maintenance schedule. He informs the Commission that state law deems that if a road has not been included on the county road maintenance map for a 20 year period, it is considered an abandoned road. He states that the Commission has the authority to adopt any / all roads they believe necessary to the county maintenance schedule; however, he does not think it is favorable to do this as it will likely lead to more requests in the future.

Commissioner Laura Cobb asks if it is legal to proceed. She reminds the Commission that she has made similar requests in the past and has been advised that it is not favorable to adopt a 911 road.

Commission Jake Durham decides after the discussion to withdraw his motion to extend 1300 feet of County Road 802.

Whereas, the Commission specifically recognizes the need and right of ingress and egress for Mr. Scott Dennis to be able to access is property, which is essentially landlocked by adjoining property owners; and

Whereas, the Commission deems the vacation of said roads in the public interest.

Therefore, the Commission hereby resolves to vacate County Roads 439 and 263 and the portion of County Roads 450 and 59 within the boundaries of Hancock Forest Management property,

Furthermore, the Commission tasks the County Engineer with conducting the publishing and filing of said vacation as required by law and delegates the authority required to draw this issue to closure including implementing whatever means necessary to invest or reinvest the abutting landowners with title to the vacated portions of the road.
