RESOLUTION FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS FOR GOVERNMENT SERVICES: COUNTY ROAD 57

WHEREAS, Cleburne County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, under the Final Rule published by the United States Department of Treasury dated January 6, 2022, the County had the option to designate a standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award of \$2,896,093, as revenue replacement ("ARPA revenue replacement funds"); and

WHEREAS, the Final Rule provides that the designation of this standard allowance is a one-time, irrevocable election that must be made for the period of performance of the ARPA funds award; and

WHEREAS, the County has duly made this election and designated its entire ARPA fund award as ARPA revenue replacement funds; and

WHEREAS, the County may expend ARPA revenue replacement funds for government services; and

WHEREAS, the Cleburne County Commission (the "Commission") has determined that there is a need to provide pay-go construction and maintenance services to ensure the safety and accessibility of County roadways

WHEREAS, the Commission has further determined it is within the authority of the County to provide these government services; and

WHEREAS, the Commission has determined that providing these services is a necessary, reasonable, and proportionate measure to facilitate the provision of these government services.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County shall conditionally allocate up to \$447,266 of its ARPA revenue replacement funds to be expended for pay-go construction and maintenance on County Road 57 (the "project").
- 2) Expenditure of the funds allocated herein is contingent on compliance with state competitive bid laws and any federal procurement requirements applicable to the expenditure of ARPA revenue replacement funds.
- 3) All bid documents and contracts awarded for the project shall include as terms and conditions the provisions of Attachment A to this Resolution.
- 4) All contractors selected pursuant to the competitive bid process shall be required to execute the certifications included in Attachment B to this Resolution, as well as submit a fully executed copy of the contractor's E-Verify Memorandum of Understanding for Employers that has been submitted through the E-Verify system.
- 5) If other funding sources are used to complete the project, ARPA funds expended for the project shall be separately tracked and accounted for.
- 6) Expenditure of ARPA revenue replacement funds, as authorized by this Resolution, is further contingent on the continued appropriation and availability of ARPA revenue replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.
