Whereas, the AVENU Insights & Analytics, LLC has presented the Lodging Tax Revenue Enhancement Agreement for renewal and for successive three (3) years term.

Therefore, the Cleburne County Commission hereby resolves to approve the contract and authorize the Chief Finance Administrator to sign.

Resolution #4946-4

Whereas, the Code of Alabama, Section 11-5-34, allows each County Coroner to appoint Deputy Coroners with the approval of the County Commission; and

Whereas, Coroner Adam Downs has asked the Commission to approve the following Deputy Coroners: Clint Cochran, Ryan Mitchell, and Paul Padgett.

Therefore, the Cleburne County Commission approves said request and instructs the Coroner to file the appointments in writing in the office of the Coroner and the office of the Probate Judge.

Furthermore, the Cleburne County Commission instructs the Deputy Coroners to file with the Judge of Probate the bond and oath of office required by law.

Whereas, the FY19 Tobacco Tax beginning fund balance is approximately \$20,000 more than previously anticipated; and

Whereas, the Commission desires to allocate discretionary funds for the use of funding projects outside the normal scope and responsibility of County Government; and

Whereas, a Discretionary Fund Policy has been adopted to ensure funds are used wisely and in accordance with local, state, and federal laws and regulations.

Therefore, the Cleburne County Commission authorizes the Chief Finance Administrator to reserve \$20,000 of the Tobacco Tax fund for discretionary use and divide it equally among the four Commissioners.

- B. County Engineer Lee Estes gives the Commission an update on routine general maintenance items. He mentions that recent rain is causing some issues with dirt roads.

- D. County Attorney Jason Odom gives the Commission a brief concerning the repairs at the Cleburne Health Department building and has forwarded documents to the Cleburne Nursing Home attorney for review.

Whereas, the Cleburne County Commission established the county solid waste collection fee by Resolution #4839-7, and

Whereas, said resolution reserves the expenditure authority for such funds to the commission, and

Whereas, some appropriate expenditures include the establishment of a Solid Waste Convenience Center, and

Whereas, the county engineer desires to establish a convenience center on property owned by the county, and

Whereas, such construction shall require a budget amendment to authorize the transfer of \$50,000. from the Solid Waste Collection Fund to the County Engineer's Environmental line item,

Therefore, Be it Resolved that the county engineer is authorized to begin establishment of said facility and to expend no more than \$50,000 from the Solid Waste Collection fees once said funds are transferred to the Environmental line item.

Discussion Items by Chairman and Commissioners

Commissioner Terry Hendrix has suggested to the Commission that Crystal Cavender, Cleburne County Emergency Manager be commended for her recognition by the Alabama Association of Emergency Managers for completing the rigorous educational and training requirements leading to her designation as an Advanced Level Emergency Manager. She has completed 700 hours of core emergency management curriculum coursework and 300 hours of management-related training. The Chairman has read aloud the letter that has been received from the Alabama Association of Emergency Managers announcing the completion of this academic endeavor. The Commission endorses this accomplishment of Mrs. Cavender.
