Comment from Citizens

Ronnie White expresses his dissatisfaction with the phone service of CenturyLink. He has called the Public Service Commission to ask them to look into the issue and he has been told by them that they no longer have authority with these issues. Chairman Ryan Robertson states that the county also has no authority and suggests that Mr. White contact state representatives.

The County Attorney states he is not familiar with the issue. He agrees that Mr. White should contact the state representatives.

Commissioner Emmett Owen asks Mr. White if the Public Service Commission has offered any suggestions as to a solution to correct the problem.

Commissioner Jake Durham suggests that the County Finance Administrator call the Public Service Commission to ask what obligations the county and CenturyLink have.

Billy Porter with Advance Disposal addresses issues with new drivers on Cleburne routes. He also addresses that missed pickups may be due to issues of similar addresses.

Commissioner Laura Cobb addresses concerns from calls she is getting by residents in her districts with missed pickups the long delays in rectifying the missed pickups. She asks Mr. Porter for a phone number for citizens to report the missed pickups.

Commissioner Emmett Owen discusses the missed pickups and the protocol for returning to the address to complete the pickup.

Commissioner Jake Durham asks Mr. Porter for a guarantee that the contract for their services be upheld.

Commissioner Terry Hendrix discusses his displeasure in the missed pickups and firmly wants a guarantee that Advance Disposal upholds the contract with the county for services.
