Whereas, Cleburne County Engineer has spoken to a grant writer to help with applying for available grants.

Resolution #5425-5

Whereas Cleburne County Engineer states that the Convenience Center at Hollis Crossroad is in need of a septic system;

Whereas, the cost of the septic system is approximately \$5,000;

Whereas, there are funds available for the installation, in the Environmental Fund;

Therefore, the Cleburne County Commission hereby agrees to allow for installation of a septic system at the Hollis Crossroads Convenience Center, using funds available in the Environmental Fund.

Resolution #5427

Whereas, the Cleburne County Commission has received notification from the Natural Resource Conservation Service, a sector of the United States Department of Agriculture, concerning watershed dam responsibilities;

Whereas, the letter states that the Cleburne County Commission is responsible for maintaining certain watershed dams within the County;

Whereas, the Commission, has requested documentation, proving that the properties in question, actually belong to the County Commission;

Whereas, after numerous attempts to receive the documentation, it has not been forthcoming;

Therefore, the Cleburne County Commission resolves to seek a Declaratory Judgment, to absolve the Commission of a responsibility for maintaining the watershed dams.
